



- Barrie Flood (CEO RemedX Remediation Services Inc.) and Sonia Kont (Senior Consultant New West Public Affairs) made a presentation to Council about the proposed Class II Industrial Waste LandfillI (proposed location is east of Hussar). Council accepted the RemedX presentation by Barrie Flood and Sonia Kont as information.
- Council provided approval to send the letter drafted by administration to the Wheatland Housing Management Board, as presented, regarding requisitions for participating municipalities.
- On March 23, 2021, Wheatland County Council directed administration to provide Council options for media relations for general training and education; as such, several options were presented to Council at the April 6, 2021, meeting. Council accepted the options for media relations for general training and education as information.
- Council approved the final 2021 2023 Operating Budget and the final 2021 2025 Capital Budget. These documents have been circulated internally and will be available on our website.
- Council accepted the April 6, 2021, broadband update as information. The updated information can be found on our website https://wheatlandcounty.ca/broadband-project/.
- Council proclaimed April 18-24, 2021 as "PITCH-IN CANADA Week" in Wheatland County and invites all citizens in our region to actively participate in PITCH-IN Week.
- Council approved the appointment of Markus Lehmann and Larry Chanasyk to the Economic Development Board, for a 2-year term expiring October 31, 2022.
- Council made a motion requesting for administration to prepare a summary report of the disposition of major assets (e.g. construction equipment). The summary report to include original purchase price, sales price and estimated operational costs over the life of the asset.
- Council also made a motion for administration to bring forward an updated cost projection for installing a gravity sanitary sewer system in Rosebud as well as costs to install a single gravity sanitary main to primarily service the new subdivision in Rosebud.
- Council made a motion for administration to approach the Town of Drumheller public works regarding the agreement made in 2011 and bring back a recommendation to Council regarding Raymond Hill.
- Council made a motion requesting county administration to contact the Town of Strathmore to inquire what their response was to the Minister of Municipal Affairs regarding cost sharing of recreational services between neighbouring communities of the Calgary Metropolitan Region Board.
- Council made a motion requesting county administration to proceed with preparing a lending bylaw for the purpose of providing a loan to the Wheatland Regional Corporation for shortfall regarding the South Truck Fill Station project; further that the bylaw be brought to Council for consideration.
- In honour of the past, present and future contributions of the seniors of this community and throughout Alberta, Wheatland County Council hereby declares June 7 – 13, 2021 to be Seniors' Week in Wheatland County.
