



- Council provided first, second, third and final reading of the Joint Regional Assessment Review Boards Bylaw #2021-28, being a bylaw to establish Joint Regional Assessment Boards, as amended.
- Wheatland County will provide funding to the Strathmore & Wheatland County Christmas Hamper Society in the amount of \$3,300.00 for 2021.
- Council approved that the Economic Development Board review the Community Futures Wild Rose presentation (Community Business Investment Partnership) with the CED Officer and bring back a recommendation to Council.
- Council accepted the Council Resolution Tracker Report dated September 21, 2021, as information.
- Council approved proposed amendments to the Wheatland County Legislative Policy Section 5.1.1 Elected Officials Remuneration, related to the Councillor meal cap and payroll submission and pay date.
- Council directed Administration to work with Town of Strathmore Administration and Wheatland Housing
 Management Body Administration to provide a professional and independent assessment of the lands needed for the
 new lodge site.
- Council approved attendance of Agricultural Service Board members and administration to the 2021 South Region Agricultural Service Board Conference hosted by Cardston County on October 6, 2021.
- Council approved rescheduling the October 6, 2021, Agricultural Service Board meeting to November 10, 2021.
- Council accepted an offer from Western Irrigation District to purchase 0.03 acres from Roll 7006000 and 0.18 acres from Roll 7012000 within NW 24-26-24-4, in exchange for the supply and installation of a domestic water turnout within Roll 7012000, valued at \$2,400, based on the information as presented in the September 21, 2021 request for decision.
- Council directed Administration to collect historical documentation regarding the transfer of road (UAR 133) from Alberta Transportation to the County.
- Council ratified the submission of the Wheatland County Resolution 'EMS Capacity and Service Delivery in Rural Alberta' to the 2021 Central Rural Municipalities of Alberta (RMA) – District 2 General Meeting for endorsement consideration.
- Council requested that the Strathmore Handi-bus request for 2021 funding be brought forward to the October 5th Regular Council meeting for Council consideration.
- Council directed Administration to request that the Strathmore Handi-bus Board present to Council at the October
 5th Regular Council meeting, providing information regarding the following: number of County users and trips,
 financial statement, approved operating and capital budget, and year to date financial information.
- The following motions arose from an in-camera session:
