



Council Meeting



March 22, 2022

- Council moved second and third reading of Bylaw 2021-31, this being a bylaw for the purpose of amending Land Use Bylaw No. 2016-01 to redesignate \pm 1.21 hectares (\pm 3.00 acres) of Lot 2, Plan 9210498 within NW-29-24-24-W4M, from Agricultural General District to Country Residential District as shown on the attached Schedule 'A' forming part of this Bylaw.
- Council moved second reading of Bylaw 2021-34, this being a bylaw for the purpose of amending Land Use Bylaw No. 2016-01 as shown on the attached Schedule 'A'.
- Council directed Administration to proceed with the communications survey presented.
- Council ratified attendance at the Strathmore & Wheatland District Chamber of Commerce Event on April 14, 2022.
- Council ratified attendance at the City of Calgary Compost and Recycling Facilities Tour on April 20, 2022.
- Council approved Reeve Link's attendance at the Community Futures Convention in Ottawa, Ontario (May 8-10, 2022).
- Council directed Administration to schedule meetings with all surrounding municipalities with IDPs/ICFs within Wheatland County excluding Special Areas.
- Council directed Councillor Laprise to draft a letter to the participants in the Conversations on Housing thanking them for the opportunity to participate in the conversations to date, sharing initiatives that Wheatland County has in place that contribute to affordable housing in the region and indicating that representatives from WFCSS and Wheatland Housing Management Board will continue updating Wheatland County Council on initiatives.
- Council moved to provide a letter of support to the Gleichen and District Ag Society for their grant applications to build the public use rodeo grounds for the inaugural Saddle Bronc Riding.
- Council directed Administration to bring back a Request for Decision with information regarding historical support for Ag Societies and events in the area.
- Council accepted the Council Resolution Tracker Report dated March 22, 2022, as information.
- Council authorized the Reeve and Chief Administrative Officer to sign the Agreement to Provide Bylaw Enforcement Services with the Village of Hussar.
- Council accepted the Community Benefits Agreement from Wheatland Wind Project Ltd. to establish an annual community benefits fund to be distributed to various initiatives, organizations, and events that benefit the local community.
- Council authorized the Reeve and Chief Administrative Officer to sign the presented Access Road Maintenance Agreement between Wheatland County and the Village of Rockyford, for the purpose of providing County-supplied snow plowing of the site access road within the public water fill station site located at the southeast corner of SE-3-24-22-W4.

- Council reconsidered Bylaw 2021-34 – Amendments to Land Use Bylaw 2016-01 as presented on March 22, 2022.
- Council requested Administration to bring back Bylaw 2021-34 - Amendments to Land Use Bylaw 2016-01 to the April 5 Regular Meeting of Council for consideration.
- The following motions arose from an in-camera session:
 - That Council approve the changes to the Wheatland County Organizational Chart, one for a seasonal position and one for Planning & Development, as presented.
 - THAT Council authorize legal expenditures for costs required to file a court injunction for the property located at SW 7-25-24-W4M.
 - That Council deny the request from Logic Energy Ltd as requested in a letter to Reeve Link dated March 16, 2022.
