



## Council Meeting



**May 3, 2022**

- Council approved first reading of Bylaw 2022-12 for the closure, and disposal to the applicant, being the adjacent landowner, of a portion of the existing, original undeveloped Municipal Road Allowances.
- Council scheduled a Public Hearing for Bylaw 2022-12 for July 5th, 2022, at 9:00 a.m. in Wheatland County Council Chambers.
- Council provided the first, second, third, and final reading of Bylaw 2022-13, being a bylaw to regulate noise which may disturb the peace.
- Council directed Administration to work with the Wheatland Regional Corporation representatives to come up with a proposal and bring back to the June 7, 2022, Council meeting.
- Council authorized the Reeve to sign the Revised Marigold Library Agreement and Schedule C per capita levy rates for 2023 and 2024.
- Council directed Administration to look into what the cost would be for the Speargrass Community Association to use the power from the water treatment plant to power their alarm systems at the Carseland RV lot.
- Council accepted the May 3, 2022, Council Resolution Tracker as information.
- Council appointed Mary Marshman as the Wheatland County member-at-large and furthermore, Council directed Administration to advertise a member-at-large position for the Drumheller Area Health Foundation.
- Council moved that Wheatland County write a thank you letter to Gary Krabsen for his time on the Drumheller Area Health Foundation board.
- Council approved that a Wheatland County Committee of the Whole be scheduled to take place on June 14, 2022, to commence following the Municipal Planning Commission meeting.
- Council authorized Administration to draft a letter highlighting Wheatland County's economic development profile, to be included in the Lakewood Homes community "regional package".
- Council authorized the Reeve to sign the Wheatland Regional Emergency Partnership Agreement, with the following amendments:
  - Add Beiseker to section 31.a.i.
  - Remove Emergency Medical Services from 31.a.viii and have it stand alone
  - Amend 'Strathmore and District Chamber of Commerce' to 'Strathmore & Wheatland District Chamber of Commerce' in section 31.a.xiii
  - Amend 'requisitioned' to 'funded' in Schedule B section 7
- Council moved that Wheatland County support the membership fees for Communities in Bloom for any community that wants to join for 2022.
- The following motions arose from an in-camera session:
  - THAT Council deny the request by Lynx Energy to reverse penalties.
  - THAT Council accepts the general comments provided by Brownlee LLP, dated April 19, 2022, regarding setback requirements for structures located within the High Eagle Campground as information.
  - THAT Council direct staff to proceed with the Development Permit process as recommended by County legal counsel and Administration.

- THAT Council direct the Reeve to send a response letter to the Honourable Minister McIver in response to the April 19th, 2022 letter from the Villages of Rockyford and Standard as presented.
- THAT Council direct Administration to work in conjunction with legal counsel to provide Council a draft demand letter for consideration to be sent out to the Villages of Rockyford and Standard to be ratified at the May 17th Council Meeting prior to sending.
