



Council Meeting



November 22, 2022

- Council moved First Reading of Bylaw 2022-24, this being a bylaw for the purpose of amending Land Use Bylaw No. 2016-01 to redesignate ± 249.78 hectares (± 617.70 acres) of Section 12-28-24-W4M, from Agriculture General District to Direct Control District as shown on the attached Schedule 'A' and Schedule 'B' forming part of this Bylaw.
- Council moved that a Public Hearing for Bylaw 2022-24 be scheduled for December 20, 2022, at 9:00 AM in Wheatland County Council Chambers.
- Council directed Administration bring back a report on the historical context of Bruce Lake and to reach out to Rocky View County, the Western Irrigation District, and the Town of Strathmore to explore future possibilities around Bruce Lake.
- Council accepted the Council Resolution Tracker Report dated November 22, 2022, as information.
- Council approved that the Division 3 Councillor be appointed as Wheatland County representation to the IDP/ICF committee with the Town of Strathmore and that Division 1 Councillor be appointed as alternate representation.
- Council accepted the Rural Renewal Program report, dated November 22, 2022, as information. Furthermore, Council directed Administration to continue intermunicipal conversations on the Rural Renewal Stream Program with the Town of Strathmore, the three Villages within Wheatland County, and Community Futures Wild Rose, and any other non-profit or private organizations and directed Administration to explore the application process as soon as possible with the Town of Strathmore and the three Villages within Wheatland County and regularly report back to Council.
- Council moved to provide a letter of support to TIU Canada for their request for project funding from the Canadian Federal Government under the Smart Start Renewables Energy Program.
- Council authorized Administration to sign a Utility Right of Way agreement with Fortis Alberta, to place a guy wire anchor and overhead powerline within that portion of 3rd Avenue, Plan 3767CN, that lies within Plan1711545, in SW 18-27-21-4, Roll 3779000, in Rosebud, based on the information provided in this request for decision.
- Council directed Administration to have legal review if extending the Telus lease agreement would constrain future options for the site and to communicate with the Town of Strathmore.
- Council directed Administration to bring back a comparison of the quote that was provided to Council on May 22, 2022, versus the engineering study and proposed costs that were developed in house.
- Council directed Administration to bring historical data on utilities to a Committee of the Whole meeting and to gather information to develop a policy for the County of Wheatland utilities.
- Council approved the amendments made to Public Works Policy 9.3.7 Snow Plowing, as presented in the request for decision.
- Council directed Administration to communicate to the Town of Strathmore our process regarding the West Side Servicing strategy, whereby we will first be deciding on a short list for potential servicing strategies and the timeline around that.

 - THAT Council direct Administration to get a quote and the scope for Council governance review.
