



Council Meeting



September 5, 2023

- Council approved First, Second, Third and Final Reading of the Code of Conduct Bylaw 2023-18, as amended.
- Council approved mileage and per diem for the Reeve for the Transportation and Economic Corridors Reception on July 9, 2023, and the CGC 2023 Cowboy Corral Stampede on July 10, 2023.
- Council ratified one partial day per diem and mileage for Councillor Ikert's attendance at the 2023 SAEWA AGM on September 22, 2023.
- Council accepted the Council Resolution Tracker dated September 5, 2023, as information, keeping the resolution no. CM-2022-08-27 as outstanding.
- Council approved the Rail Safety Week Proclamation from September 18-24, 2023.
- Council approved the attendance of the Reeve and Councillor Biggar at the proposed meeting and expresses its support for the concepts of the Chara Seniors Community, highlighting Council's dedication to innovative, affordable seniors' housing.
- Council approved the draft Council Remuneration Committee Terms of Reference, as presented.
- Council authorized the Reeve to sign a letter of support to be sent to Rosebud Theatre and School of the Arts to be included in its application to the CFEP program for roof replacement on the Mercantile Building and rehabilitation of the property, including pond, waterfall, awning, and waste management area.
- Council approved the submission of the Wheatland County Resolution 'Enhancing Home Care Services for Rural Residents in Alberta' to the 2023 Central Rural Municipalities of Alberta (CRMA) – District 2 General Meeting for endorsement consideration.
- Council instructed either the Reeve or the Chief Administrative Officer to seek a seconder endorsement from a CRMA member municipality for the resolution titled "Enhancing Home Care Services for Rural Residents in Alberta".
- Council approved the submission of the Wheatland County Resolution 'Review of Affordable Housing Funding Programs' to the 2023 Central Rural Municipalities of Alberta (CRMA) – District 2 General Meeting for endorsement consideration, as amended.
- Council instructed either the Reeve or the Chief Administrative Officer to seek a seconder endorsement from a CRMA member municipality for the resolution titled 'Review of Affordable Housing Funding Programs'.
- Council removed Deputy Reeve Klassen from his position as an alternate on the Wheatland Housing Management Board (WHMB), following the request of the WHMB's Chief Administrative Officer and in alignment with the Alberta Housing Act, and to refrain from appointing any further alternates to this board.
- Council approved its annual cash contribution to the Strathmore Handi-bus in the amount of \$10,000 and a contribution to the Strathmore & Wheatland County Christmas Hamper Society in the amount of \$3,300 with funding to come from the approved 2023 operating budget.

- Council directed Administration to invite the Handi-bus to present at a future Public Presentation Committee Meeting.
- Council extended the subdivision endorsement deadline for application SD2021-008 to September 5, 2024.
- Council extended the subdivision endorsement deadline for application SD2022-010 to December 12, 2023.
- Council directed Administration to communicate to the Wheatland Regional Corporation that the County supports the initial requests by Redland residents to establish individual potable water service connections by means of the Wheatland Regional Corporation water distribution system.
