



Council Meeting



February 6, 2024

- Council undertook the scheduled Public Hearing and moved First, Second and Third Reading for Bylaw 2023-27, this being a bylaw for the purpose of amending Land Use Bylaw No. 2016-01 to amend regulations for Development Permits Not Required and the Hamlet Residential General District.
- Council approved registration fees, one full day per diem, and mileage for Reeve Link attend the Emerging Trends in Municipal Law Event in Calgary, Alberta on February 8, 2024.
- Council approved Deputy Reeve Klassen's attendance at the Alberta Care Spring Seminar 2024 in Camrose, Alberta, from February 28 - March 1, 2024.
- Council ratified three full days per diem, one partial day per diem, and mileage for Deputy Reeve's attendance at the 2024 Provincial ASB Conference in Lethbridge, Alberta, from January 22-24, 2024.
- Council accepted the February 6, 2024, Council Resolution Tracker as information.
- Council directed Councillor Biggar to present the topic of Wheatland County's Board membership and the potential for increased business owner participation to the Strathmore Wheatland Chamber of Commerce (SWCC) Board for discussion at the next SWCC Board Meeting.
- Council directed Administration to write off the Commercial Vehicle Inspection Program (CVIP) invoice for July-December 2023 in the amount of \$3,750.00 for the Strathmore Handi-Bus and provide this service as in-kind.
- Council approved the Intermunicipal Collaboration Framework Agreement between Wheatland County and Rocky View County and authorized the Reeve and Chief Administrative Officer to sign the agreement for a term of four years from March 1, 2024 to December 31, 2028.
- Council refused the request to waive the \$25,000 security deposit required in accordance with Condition #7 of Development Permit DP 2023-152.
- Council extended the subdivision endorsement deadline for application SD2022-010 a second time, to December 12, 2024.
- Council approved the Town of Strathmore – Wheatland County Recreation Cost Sharing Agreement Extension and authorized the Reeve and Chief Administrative Officer to sign the Agreement.
- Council authorized the Reeve and Chief Administrative Officer to sign the Road Acquisition Agreement for the widening of a portion of the Range Road 242 Public Road Allowance as described in the report.
- Council approved the revised Snow Plowing Policy as presented.
- Council directed Administration to investigate options for funding reserves for each hamlet to address abandoned building concerns.
- The following motions arose from an in-camera session:
 - THAT Council directs Administration to proceed with adding Wheatland County as claiming Tax Forfeiture status with the Land Titles office to the property listed as roll #2770164 – plan: 632AF block: 5; lot: 7; Certificate of Title: 951 159 579.
 - THAT Council authorizes Administration, upon completion of attaching Wheatland County's Tax Forfeiture claim to the title, to proceed with negotiations for the sale of property roll #2770164.
