

## Wheatland County Agricultural Service Board Environmental Stewardship Awards

The Wheatland County Agricultural Service Board (ASB) is committed to strengthening, promoting, and supporting agriculture and the environment within our municipality with a view to continually improve how we operate in future years. The ASB develops and implements programs and policies that focus on the areas of weeds, pests, soil and water conservation, and environmental issues for the benefit of all residents.

**The Wheatland County ASB presents the Environmental Stewardship Award as a way to recognize and reward notable efforts within the community to practice and promote environmental stewardship and innovation.** Three Environmental Stewardship Awards are available per year in the following categories:



### COMMUNITY STEWARDSHIP

The Community Stewardship Award recognizes a Wheatland County community member or group that has made an outstanding contribution to environmental sustainability in the municipality. The award will honor notable projects, programs, or activities performed by businesses, individuals, or community groups, in an effort to acknowledge the people and organizations that make Wheatland County a great place to live and work.

All Wheatland County community members and groups are eligible for this award, including all ratepayers, landowners, renters, hamlet residents, businesses operating within the County, and organizations at work within the municipality.



### YOUTH STEWARDSHIP

The Youth Stewardship Award was developed to recognize the importance of engaging youth in environmental stewardship initiatives, as the youth of today represent future generations of the Wheatland County community. We are proud to acknowledge the achievements and involvement of our youngest community members, as they inspire us to lead by example and sustain our environment for their benefit.

The Youth Stewardship Award will be awarded to an individual or group of individuals under the age of eighteen who have shown leadership or strong interest in environmental stewardship. Wheatland County residents, community groups, and school groups are eligible for this award.



### J. LASLO LEGACY

This award is named in honor of the retirement of Wheatland County employee Mr. Jim Laslo. Mr. Laslo's passion for education and outreach about agricultural conservation initiatives, and dedication to harnessing the power and innovation of the agricultural community, lead to the uptake of sustainable agriculture practices throughout the municipality.

The J. Laslo Legacy Award will be awarded to an agricultural producer in Wheatland County that has shown leadership in the implementation of beneficial management practice. The winner is dedicated to reducing the environmental impacts of their operation, and has an interest in promoting positive efforts to others in the industry.
