# **Municipal Requisition**

Wheatland Housing Management Body (Wheatland Lodge) has been one of over one hundred provincially legislated Management Bodies providing subsidized Seniors Lodges in coordination with local municipalities and the Provincial government. The provincial and municipal governments recognize that Senior Citizens would be unable to pay the entire costs of supportive lodge accommodation and authorized these agencies to pass the annual revenue shortfall on to the taxpayers of the geographic area. Wheatland lodge requisitions Wheatland County, Town of Strathmore, Village of Rockyford, Hussar and Standard for its operating shortfall and funds necessary to maintain a modest reserve for capital replacements.

Wheatland Housing Management body manages a variety of housing programs and services, and the monies collected through requisitions are dedicated to supporting the Lodge operations of Wheatland Lodge. The Lodge provides accommodations to seniors over 65 years of age. Services include a single room, meals and snacks, weekly housekeeping, recreation, and homecare services contracted Bay Shore Home Health.

The individual Municipalities are not responsible for generating this amount on personal property tax bills, though they collect the amount and forward it to Wheatland Housing Management Body.

Good Morning Brian,

In reply to your email about WHMB requisitioning Municipalities for the lodge hospice. This was a motion made a year or so ago when the hospice society was added to WHMB's Ministerial Order. The proposed requisition amount would be for the operating costs of the Hospice. According to Article 8 of the Alberta Housing Act: (Other Municipal Contribution), other municipal contributions may be requested if all municipalities agree. When board members took this motion back to their council every council verbally agreed. Fast forward to COVID and the Hospice Society made the decision to not go forward at this time with the requisition.

I understand from my housing advisor that requisitioning for the hospice would definitely be a process and may or may not be approved.

In regards to the \$450,000 requisition amount. I have been here for 12 years and this has never been questioned. When the cost of operating increased to more than the budget was able to provide WHMB requisitioned for more money. I have never seen where the costs or requisitions were changed on an annual basis as operating costs continue to rise and we support seniors with low income. Any extra revenue has been maintained in reserves for capital costs example (this year the Argo therapeutic tub needs replacing at a cost of approx. \$23,000) Air con was replace at a cost of \$30,000. The Lodge is 60 plus years and everything is aged and extra maintenance and costs arise monthly. We have bee able to keep the building in good repair due to having the available capital. I hope this answers some of councils concerns.
